II. Public Comments	Modifications and Approval of Agenda No modifications Motion: Edward Evans Second: Nikisha Williams Vote: All present voted in favor. See attached voting sheet. No public comments.
III. Financial Presentation	 Financial Update FY19 Year End Net Income (Unaudited Actuals). Final operating income higher than previous forecast by \$352k through June 30. Increase in net income primarily due to major expense savings. In the areas of: Parent workshops, health benefits, stipends and legal expenses spent less projected. 2018-19 Monthly Cash Balance – ended June with \$3.54 million in cash. Maintaining a healthy balance. 2019-20 State budget – signed budget. No substantial change from May revise to Governor's signing in June. The LCFF (COLA) has remained the same at 3.26%. STRS increases from 16.7% in FY20. 2019-20 Forecast Update – July forecast increased by 44k since budget was approved. Original budget is at 174k projecting it to be at 218k by Fall. Increase coming from federal lunch program.

	 2019-20 Monthly Cash Balance – Cash forecasted to remain above \$3 million through FY20. FY21-FY25 Renewal Budget – Possible increase in STRS, Epenses and Payroll. Legislative Update – AB 1505 on track to be approved, AB 1507 TBD on amendments. AB 1505 more discretion given to district to deny new charters, appeals process change. AB 1507 Senate vote to occur Sept. 13, governor to sign/veto by Oct. 13. After charters operating outside of authorizer boundaries. Key Takeaways of AB 1505 – in effect July1, 2020. Appeal rights, certificate of clearance required for all teachers, fiscal, community & academic impact, three renewal tracks, data compared to statewide average.
